The Government of Nepal has allocated funds towards the cost of **Water Supply Project** and intends to apply part of the funds to cover eligible payments under the Contract for **Yek Ghar Yek Dhara Nirman Project DRM-2, Lulang and Contract identification No. DRM/MYAGDI/NCB/Ws/01/2077-078**. Bidding is open to all eligible Nepalese Bidders.
2. **Dhawalagiri Rural Municipality** invites electronic bids from eligible bidders for the construction of **Yek Ghar Yek Dhara Nirman Project DRM-2, Lulang** under National Competitive Bidding procedures.
Minimum Work experience of similar size and nature: **Construction of at least one (1) water supply project within last 10 years, with a value of at least NRs 10 Million that has been successfully or substantially completed and that are similar to the purposed works.**

Bidders, submitting their bid electronically, should deposit the cost **Rs. 3000** of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Electronic bids must be submitted to the office **Dhawalagiri Rural Municipality, Muna-Myagdi**, by through PPMO website www.bolpatra.gov.np/egp before **12:00 noon** on **2077/07/04 (20th Oct, 2020)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm**



on 2077/07/04 (20th Oct, 2020)) at the office of **Dhawalagiri Rural Municipality, Muna-Myagdi**. Bids must be valid for a period of **90(Ninety days)** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **as mentioned at para 10** which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing / submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
